The meeting was called to order by Supervisor Edward Hunt at 6:00 p.m.

Supervisor, Ed Hunt, gave the fire report. Next meeting will be January 20, 2026. There will be a meeting in Mid-February with the insurance provider to go over the renewal quote, Ed is trying to be present for that meeting. There is thought of replacing the tanker that was new in 1995.

Supervisor, Ed Hunt, gave police report. Deputy Fini completed 57 stops in the month of November with a total of 17 citations. She also completed 4 non-criminal calls and 3 crash investigations. The police car has about 55,000 miles on it, which was a question from the previous meeting. Ed also addressed complaints about the township car being seen outside of the township.

Supervisor, Ed Hunt, gave a road report. Winter is here.

Supervisor, Ed Hunt, gave a building and grounds update. The furnace is acting up still and is struggling, it is advised that it be replaced in the next few years. The repair service man was up in the ceiling and said that the insulation in the building will need to be updated as that it has settled a great deal and is patchy and this results in the furnace has to work harder.

#### **Brush Program 2026:**

In an effort to get more townships to have the county spray their brush the county is offering to mow with the application of ditch spray. The Road commission is aiming to purchase a tractor with a mulching head with a 20ft boom arm to make mowing easier and more effective. Discussion was had on opting in to more brush spray, how much to spray and whether or not the road commission would be able to handle demand for mowing.

#### **Pedestrian Signs:**

There are 2 pedestrian signs and 1 tractor sign located on Barnes rd, between Bray and Barkley. These signs are dated from the 1990's and if they were to be replaced when the road is repaved next year, it would be at the townships expense.

#### **Schiefer Rezoning:**

The planning commission recommended after their October 27<sup>th</sup> Meeting to approve the request from Amy Schiefer to rezone approximately 1.5 acres from agricultural to residential for the purpose of zoning continuity in keeping with the township ordinances and master plan.

**Cyber Insurance Coverage:**

Discussion was had about opting into including Cyber Insurance Coverage at renewal of the township insurance. Discussion was had about what was included and covered with this coverage.

**EMC Insurance Renewal:**

Discussion was had about the renewal of the EMC Insurance policy. They included a 4% increase in building coverage but it was recommended that we have a contractor value the building for a catastrophic loss price in the event that something unfortunate happens. This would make sure that we are still within the bounds of what we are covered for in the event something does happen and the entire building would need to be rebuilt.

The original \$75,000 from Ranger Power to review their application and pay for other legal fees was not enough. Kyle from FSBP will be sending a request to them for the remaining portion, \$50,708.16 plus \$14,550.00.
